

My First Three Months... By Reverend Anthony Coci

My first three months as pastor have been excitingly chock-full of ministry and engagement. It is energizing to see our parish alive with baptisms, weddings, and young people. My goal is to expound upon these areas and continue to grow our parish. Pastoral Council members and I recently attended the Toledo Diocesan Conference "Acts XXIX" hosted by Fr. John Riccardo. Bishop Thomas invited Fr. Riccardo and his team to lead our parishes in a renewed way of thinking and planning for the future. The conference was based on reacquiring a biblical worldview, cultivating strong leadership, and prayerfully discerning God's plan. The Conference ended with some reflection questions for each of us to pray over and discuss as we seek the best ways to serve you and others in our parish community. We are in the initial stages of this process, so please pray for us.

Fr. Riccardo shared a story about a woman who was very distraught and on the verge of suicide. He politely asked her if he could share his worldview with her, and by the time he was done she was in tears and realized that she has meaning, purpose, and an identity as a follower of Jesus Christ. Fr. Riccardo then told us that we must be able to articulate our Christian worldview in about 5 minutes to modern people so that they can understand the Christian proclamation. He then gave as a rubric. The story needs to answer four questions: Why is there something rather than nothing? Why is everything so messed up? What, if anything, has God done about it? If He has done anything, then how should I respond? Then he boiled it done to four words: Created, Captured, Rescued, and Response.

With that in mind and seeing as how I am still getting to know most of you, I would like to share with you part of my story based on this four-point structure. First, why is there something rather than nothing? I answer this from the standpoint of gift; my life is a gift. I did not create myself, but rather I received my body and soul. I grew up with a loving mother, father, and two brothers. We

played a lot of family games, like euchre. Mom made birthdays and holidays special by inviting a lot of people over to celebrate. Dad imparted to me his love for the great outdoors with a passion for fishing and hunting. There are a lot of things that I did not create that I am the beneficiary of in my life, and for these and many others I am truly grateful. Second, why is everything so messed up? I answer this question by sharing one or two hard times in my life, and how I managed through them. For example, junior high school was a tough time for me. It was an awkward growth period for me, and I was bullied. I disdained going to school. My parents asked me if I wanted to switch schools, and I said yes. This shift from the public to the Catholic school was a pivotal moment that set me on course to become a priest. I do not know if I would be where I am at today without the suffering of my past. Hence, I share with people that God did not create suffering. That is a result of sin, which is a cancer that has been spreading throughout human history, but where there is suffering is great opportunity to experience great love. Third, what has God done if anything about it? For me this is where the Cross makes sense. If God is going to communicate to us, which I believe He has and is, then He is going to do so in a way that we can understand. He is going to speak to us in a human way. He was born into the ancient religion of Judaism, where all the great prophets foretold his coming. He came as a baby, had friends, shared stories, worked hard, was rejected, died, and rose from the dead. He was an average man like me sharing average things like me, but he did something extraordinary for me. He conquered death. He did battle on the Cross for me, so that I may have the opportunity to live on past death. When I meditate upon the Cross I cry because I know I am not worthy, but he loves me despite my unworthiness. As I gaze upon the crucified Christ, the words of the Gospel ring true in my heart, "No greater love has this than to lay down one's life for one's friends," (John 15:13). Fourthly,

if God has done anything about how messed up the world is, then what is my response? My response is to love Him with all my heart, mind, strength, and soul, which means I will love Him, and I will love everyone and everything He has created. What can I return to God for His love to me? Roses? No. A Maserati? No. The only thing I can return to God is a perfect life of love. But I am not perfect; therefore, I need help to make my love perfect (i.e. Jesus). In the Catholic Mass I join myself to Jesus Christ in a perfect offering back to the Father, which is His very Son. Only Jesus can return perfect love back to the Father. The more I conform my life onto to Christ, then the more love I begin to experience. God revealed how He wants to be loved, which is found in the Mass by the obedience of our hearts to a life of sacrifice united to His Son. In summary, I find my purpose, my meaning, my identity in my relationship to Jesus, and no one can take that away. By sharing our stories in the context of our Christian worldview we can awaken others to their ultimate identity as beloved sons and daughters of God.

I look forward to sharing stories as we journey together as brothers and sisters in Christ over these upcoming years. Many of you I have already met, and the remainder I look forward to sharing fellowship at church, around your kitchen tables, and out-and-about in public. (I'm about a third through my "Fr. Anthony-Parishioner Meals" list, so if you have not yet received a call from me, please stay tuned because it is coming. Thanks for your patience.) Please be assured of my continued prayers for you and commitment to our parish family!
